## PUBLIC HEARING AND REGULAR IN PERSON MEETING

Chairman Storms called the Public Hearing to order at 5:00 p.m., no one having appeared, the Public Hearing was closed at 5:01 p.m.

Chairman Storms called the Regular Meeting to order at 5:01 p.m.

**Minutes:** Approval of the minutes from the March 6 meeting. Motion was made by Mrs. Latremore, seconded by Mr. Florence to approve the minutes. Motion passed unanimously, carried.

Village of Carthage Business: None

**Village of Deferiet Business:** A question was raised about why National Grid took down the 115KW power line that ran the mill. Because that has been removed, the Solar project for the mill site is now null and void.

**Town of Wilna Business:** A lot line adjustment application was presented by Sandra Hill and Calvin Marolf for property on County Rt. 42. They own both parcels in question. They propose to move the lot line on lot 77.00-1-31.1 over to lot 77.00-1-31.2. A survey is being prepared. Motion was made by Mr. Dutton, seconded by Mrs. Skvorak to approve the lot line adjustment pending the survey being obtained. The survey is to be dropped off to Lori Borland, Secretary, and have Chairman Storms sign it, then present it to the County for recording.

Together with the lot line adjustment, Ms. Hill and Mr. Marolf want to do a subdivision, and they have submitted the application. This would subdivide parcel #77.00-1-31.1 into two lots. A public hearing will be on May 1, 2024 at 5:00 p.m.

A subdivision application has been received by Michael & Jennifer Traylor for property on County Rt. 42. The survey was provided and a public hearing is set for May 1, 2024 at 5:00 p.m.

RIC Energy public hearing had no one present. The Jefferson County Planning Department noted some local concerns only. These concerns were addressed as follows:

- 1. Natural Bridge Fire Dept. access has been brought up to Jason O'Meara, and RIC is awaiting a response.
- 2. Written statement is needed from Wheeler-Sack Airfield indicating no concerns
- 3. Wildlife safe fencing will be fine using the chain link fencing as proposed.
